RESOLUTION 38
REGARDING INSTALLATION OF WOOD FLOORS

WHEREAS, Section 5.11 of the By-Laws of Darlington Ridge Condominium Association, Inc., states: "The Board shall have and exercise all lawful powers and duties necessary for the proper conduct and administration of the affairs of the Association and the operation and administration of the affairs of the Association and the operation and maintenance of a residential condominium project and may do or cause to be done all such other lawful acts and things as are required by law, by the Master Deed, by these By-Laws or otherwise directed or required to be done or exercised by members of the Association, or Owners of Units, or by others"; and

WHEREAS, the Board of Trustees has determined a need for a published and uniform policy on installation of interior wood floors;

NOW, THEREFORE, BE IT RESOLVED THAT:

1. Wood floors on second or third stories may be installed if they are engineered floors with sound barriers/insulation.
2. Such floors may be installed during Monday through Saturday only between the hours of 8:00 a.m. and 8:00 p.m.
3. Anyone seeking to install floors on second and third stories must submit a modification request form and procure Board approval before starting work.
4. Noncompliance with this resolution shall result in the imposition of fines, sanctions, remedies, etc. as permitted by the Governing Documents and State Law.
